# Introduction

# Why Mediation?

---

There are many reasons to choose mediation over litigation. Here are 3 good reasons why you should mediate your divorce.

## Reason 1: Cost.

The cost of hiring an independent, unbiased mediator to assist you in designing your own settlement is always much less than hiring multiple attorneys, accountants, and financial advisors. Attorneys, typically, foster an adversarial approach to resolution of issues, necessitating both sides to hire multiple specialists and pay astronomical professional fees in order to protect legal rights, many times leaving both parties to the dispute stripped of all financial resources. *The average couple will spend between \$5K - \$10K just to get started - with trial typically costing the same couple an additional \$10K each.*

## Reason 2: Build on the Positive.

Mediating instead of litigating gives you the opportunity to build a positive future as you move forward with your lives in different directions, instead of a negative one. By conserving financial resources, communicating and showing respect instead of fighting, taking control of your family's future and making your own choices, and viewing your separation from the perspective of a team instead of as adversaries, all parties can maintain their mental, emotional and physical health and move into the future in a positive way.

## Reason 3: Control

Litigation leaves you in a position where attorneys and judges make the important long-lasting decisions that affect you and your family. # Part I: Process

## Paperwork Walkthrough

---

Step 1: I will provide the packets for your dissolution of marriage.

Step 2: Fill out the paperwork. If you have any questions about the paperwork, leave blank and bring to mediation.

Step 3: Use this link to » [Schedule Your Mediation](#) or you can text 561-262-9121 , or email at [mbrickman@ichatmediation.com](mailto:mbrickman@ichatmediation.com).

Step 4: If you have minor children together, go to the [Self-Representation Page](#) and click on the [Florida Online Coparenting Education](#) banner to take your parenting class. Print out your certificate of completion and bring to mediation. If you do not have minor children together, then skip this step.

Step 5: Bring all paperwork to mediation.

Step 6: If an agreement is reached in mediation, after mediation, you will need to file all of your paperwork yourself or proceed to Step 7.

Step 7: OPTIONAL: Hire attorney to file your paperwork for you take you through final hearing to expedite the process. If you do not hire an attorney for final hearing there will be at least 1 status conference to attend with the court prior to getting a date set with the judge for your final hearing.

Step 8: Go to final hearing to get your certificate of divorce.

# Part 2: Cost

## Cost Breakdown

---

- 1: Your initial cost will be to obtain your packets. They run approximately \$25 and are included in the mediation fee below. I can provide the documents to you.
2. Your next cost will be to each pay for your parenting class if you have minor children together. The cost is \$39 each and payment is made to the provider of the course. This discounted price is available if you click the banner on the [Self-Representation Page](#).
3. Your next cost will be for mediation. For pricing click on the following link: »[Pricing](#). This cost is paid to the mediator at the conclusion of mediation.
4. Your next cost will be to file all the initial paperwork with the clerk of court. The cost is \$420 and is paid to the Clerk of Court or if you hire an attorney for final hearing, they will pay this cost and then you will reimburse the attorney. This cost shall be due when you file your documents.
5. Your final cost, which is OPTIONAL, is to hire an attorney to file your paperwork and take you through final hearing. Approximately \$500, depending on who you hire, and is paid to the attorney when you hire him/her.

# Part 3: Timeline

## Divorce Timeline

---

1. By providing approximately 24-48 hours of notice, Matthew is available to mediate during the day, in the evening or on weekends to accommodate your work and family schedules.
2. Once mediation is concluded and if a resolution **IS NOT** achieved, a court date could be anywhere between 4-6 months away and you will most likely be required to mediate again 10 days prior to your court date depending on the rules of the court in your jurisdiction.
3. Once mediation is concluded and if a resolution **IS** achieved, a court date could be anywhere between a month and a few months depending on the time of year your paperwork is being filed, how back logged the court is and which courthouse the paperwork is being filed at.
4. Once mediation is concluded and if a resolution **IS** achieved, if you hire the attorney to do your final hearing as previously mentioned, a court date could be a week or so depending on your schedule, as well as the judge and the attorney's availability.
